### JOB SUMMARY

- 1. To provide support and advice, including treatment planning/case discussions on complex patients with/for colleagues working within the service.
- 2. To be the named trainer for a trainee in special care in the CDS.
- 3. To provide clinical care to priority groups, on referral from other members of the service.
- 4. To provide clinical care from any Bromley Healthcare premises or any other appropriate setting, including domiciliary care, according to the needs of the service.
- 5. To provide clinical care under conscious sedation or general anaesthesia as required.
- 6. To assist the Clinical Director in the development and provision of an evidencebased service using staff development and the appropriate management of resources.
- 7. Providing guideline updates in relation to special care dentistry, acting as safeguarding lead, providing staff training as required.
- 8. To lead and deliver clinical audit programmes and participate in waiting list initiatives
- 9. Assist the Clinical Director of Dental services with any clinical matters relating to special care dentistry and undertake duties as delegated by the Clinical Director.

### MAIN DUTIES AND RESPONSIBILITIES

- 1. Maintenance of professional standards in the care and treatment of patients including the implementation of appropriate policies and procedures e.g. current guidelines in the field of special care dentistry, infection control, management of dental instruments, equipment and materials.
- 2. To undertake appraisals, personal development plans and job plans for other dentists working within the service on behalf of the Clinical Director.
- 3. To carry out clinical dentistry at any Bromley Healthcare dental surgery or any other appropriate setting according to the needs of the service.
- 4. Maintenance of accurate and detailed clinical, administrative and statistical records.
- 5. To observe confidentiality of records and health information at all times and to be aware of and practice the principles of the Data Protection Act of 1984.

6. To assist and advise Dental Officers and Senior Dental Officers in providing **Bromley** Special Care Dentistry for those with Special Care Needs as required.
